# Buckeye Morgan Horse Sale LLC

We are accepting consignments of Registered Morgan horses for the June Buckeye Morgan horse sale, to be held June 4 & 5, 2010 at the Ashland County Fairgrounds, 2047 Claremont Ave, Ashland, OH 44805. Consignments will be accepted Jan 15, 2010 - March 31, 2010 or **until filled**.

We will be selling horses 2 days, Friday June 4, 2010 and Saturday June 5, 2010

The commission fee will be eight percent (8%) of the first \$10,000.00 and six percent (6%) of the balance over \$10,000.00 with a minimum fee of \$100.00 per horse. The consignor will have the privilege to no sale (Pass Out) his horse. If the horse is passed out, the cost to the consignor will be 8% of the highest bid with a minimum fee of \$100.00 per horse.

All horses **MUST** be registered with the American Morgan Horse Association or the Canadian Horse Registry and all registrations are to be in the current owners name and the owner shall sign them before any monies are transferred. If registration is pending, a letter from AMHA must accompany your consignment form.

The sale committee will be inspecting horses, however, the owner's statement of soundness will be announced from the auction block. The Buckeye Morgan Sale committee reserves the right to reject any horses for any reason including, but not limited to: unsoundness, poor physical condition and improper documentation of health requirements.

**If a horse becomes unable to sell because of death or sickness a substitute may be used, but the sale committee MUST be informed of the change and approved by the sale committee. A Vet certificate of death, sickness or unsoundness must accompany the request. If a horse is sold or the owner is unable to make a substitution before the sale date a fee of \$200.00 per horse must be paid. ALL SUBSTITUTIONS MUST BE APPROVED BY THE SALE COMMITTEE.**

All horses **MUST** have flu and Rhino shots within the last 6 months and no later than 21 days prior to the sale. This must be included on your health papers and signed by your Vet. Each horse must also have a negative Coggins test within 12 months of the sale and an interstate health paper within 30 days of the sale. Canadian horses must have International health papers for transport between countries. Also note that anyone All mares sold Vet checked in foal, if questionable, must be checked at the buyers expense before leaving the sale grounds. If found not to be in foal, it will be the sellers expense.

All mares not Vet checked in foal are assumed to be open and sold as such. All bred mares or mares that have a foal by their side **MUST** have a signed foal registration application.

We will sell in order, as printed in the catalog. If you want a pair of horses to be sold together, you must inform us when you send in your consignment. If you do not, we will not change the sale order to sell them together.

All 'NO SHOWS' are subject to a \$200.00 fee per horse, unless a signed Veterinarian certificate of unsoundness or death is received by the sale committee. Any outstanding fees will prohibit you from selling a horse until the debt is paid in full.
